- b- At least 10 percent seats in the school will be reserved for the meritorious children of scheduled Castes/Scheduled Tribes and they will not be charged the prescribed fees for different classes in the schools run by the Uttar Pradesh Secondary Education Council/Basic Education Council.
- c- The institution will not demand any grant from the state government and if the school in recognized by the Board of Secondary Education in the past and the affiliation of the school is obtained from the Central Board of Secondary Education New Delhi/ Council for the Indian School Certificate Examination, New Delhi If it happens, then from the date of getting affiliation from the said examination councils, the recognition from the council and the grant from the state government will automatically end.
